



AGREEMENT

called hereafter "The Partner"

PURPOSE

MUL intends to support international student mobility of talented and committed students of The Partner through a special scholarship offer, the MULgrains. In addition to supporting young students, this is also meant to strengthen and further develop the cooperation between both universities.

MUL and The Partner have agreed on the Terms and Annex below which form an integral part of this agreement:

TERMS

(1) Services of MUL

With this agreement, MUL provides The Partner with scholarships amounting to **thirty two (32) MULgrains for two years (each year 16 MULgrains)** under the conditions specified in Article (2).

The benefits of a MULgrain include:

- Waiving the tuition fee
- free accommodation in mineroom student dormitory in Leoben for the duration of the study period during a winter or summer semester for a maximum of 5 months
- Monthly food vouchers for meals at the Mensa Club canteen worth € 60,-/month

Detailed information can be found in Annex I.

Cash redemption of the benefits is excluded.

(2) Conditions for MULgrain funding

The benefits of a MULgrain can only be received by an international mobility student of The Partner within the framework of his/her successfully completed study stay at the MUL. The successful completion of the



study visit is given if the student positively finalises a minimum of 20 ECTS credits within the scope of his/her stay at MUL - however, this must be completed within the timeframe of one academic year from 1 October to 30 September.

(3) Services of The Partner

The partner advertises at their university a study period abroad at MUL with the possibility of a MULgrain scholarship.

By means of an appropriate selection procedure, the partner ensures that a MULgrain grant is only awarded to talented and committed students who are professionally capable of fulfilling the conditions set out in Article (2).

In the course of the nomination of students at MUL, the partner shall communicate those students to whom it has awarded a MULgrain.

(4) Repayment of MULgrains

If the partner has awarded a MULgrain to a student of his or her university who has not fulfilled the coursework requirement mentioned in Article (2) to the extent of 20 ECTS, the costs incurred within the framework of this MULgrain must be repaid by the partner to the MUL. [MUL notes that the costs listed in Annex 1 relate to one semester only and may increase in subsequent semesters.](#)

(5) Contact persons

(6) Enter into force and duration of the contract

This agreement becomes effective upon signature by both parties and is valid for **two academic years, until the 31st July 2027. It can be extended for further two years by mutual written agreement.**

(7) Place of jurisdiction

If an acceptable resolution concerning its conclusion, invalidity, nullity or termination, as well as in connection with this contract cannot be reached within a reasonable period, the parties agree that any claim or dispute shall be governed by the laws of the land and subject to the jurisdiction of the courts where the defendant has its official seat.

(8) Versions

This Agreement is written in English and Portuguese in two copies, one for each party.
